Rules and Regulations:

Every participant pays a fee for attending **Dora Schwarzberg Instrumental Music Academy 2018**.

The Dora Schwarzberg Instrumental Music Summer Academy 2018 exists for its participants, but in return expects that the following rules be observed:

- We expect sustainable cooperation with the administration of the **Instrumental Music Summer Academy 2018**.
- Participation is only possible for the entire course period, with an arrival on July 14th-15th 2018 and departure on July 28th 2018. Official opening meeting will take place on July 15th 2018, 15:00! Under ordinary circumstances late arrival or early leave is not acceptable. Exceptions are of course allowed in the cases of illness or another force majeure. If a participant must arrive a day later or leave a day earlier because of a solo concert, the Course Administration must be notified in application form in "Comments/Special requests".
- Registration is on July 15th, from 9 until 12 am, and not during official meeting at 15:00! The schedule will be planned and fulfilled by teachers. All participants (solo course and chamber music course) will get 5 lessons in total.
- Attendance of your colleagues' lessons is advisory.
- Teachers' time is valuable and limited. It is of most importance that the participants arrive to lessons in a timely fashion, that being not later than 5 minutes before lessons begin.
- Performing on stage during a public concert is only possible in the appropriate concert attire: for men, black-and-white or all-black; for women a concert gown covering knees. Performing in casual clothing (e.g. jeans) is not permissible.
- The daily schedule is binding. The detailed schedule will be distributed upon arrival.
- Any kind of drug or alcohol use is strictly forbidden and will lead to immediate disqualification and departure.
- The students of the **Dora Schwarzberg Instrumental Music Summer Academy 2018** hereby gives his or her consent that image and audio material from the concerts can be used for promotional purposes without financial compensation, for example on the festival homepage, YouTube, radio, television and print.
- Children under 12 years **have to be accompanied by a parent** over the whole time!
- Do not leave your personal belongings unattended. **The Dora Schwarzberg Instrumental Music Summer Academy 2018** team does **not** take any responsibility for loss of your personal belongings.
